ACA Note - Graduate Assistants who have a 3/4 time appointment and are enrolled in the Consumer Driven Health Plan (CDHP) insurance which is offered due to ACA requirements (in addition to the student health insurance) will need an additional \$428.57/month budgeted. This cost should be included in the "other" category of your budget.
